# **Privacy and Security**

Cloud services store information in a variety of locations. We have conducted reviews on Microsoft Office 365 and G Suite and are satisfied that the personal information of our students is secure and safe.

<u>Microsoft Office 365:</u> Currently, data is stored on servers in the United States and Canada. At our request, Microsoft is moving most Department of Education data to servers in Canada in the near future.

G Suite: Data is stored in servers worldwide.

We are committed to protecting the privacy of our students' personal information, wherever it is stored or accessed. While this is not an educational requirement, the use of these tools will be valuable in your child's education. Yukon Department of Education will provide each Yukon student an account in both of these services that will remain with them until they graduate.

On the reverse side of this letter you will find a form; it is only to be completed if you wish to opt out. If you choose to opt out, please return the form to the school by Sept. 20, 2019. In that case, students will be provided alternative activities that do not require access to these services.

Teachers will provide students further instruction on how to access the new collaboration systems. Please note that none of these services disclose personal information to third parties or use personal information for advertising purposes.
